In April 2021, Andrew Gutmann mailed a letter to every family of his daughter's New York City private school, the Brearley School. The letter objected to the school's divisive obsession with race and identity, its abandonment of academic excellence and open discourse, and its adoption of what we now call woke ideology. The letter went viral, and was read by millions.

The letter served to ignite the parents movement and the fight against woke schools - the same movement that propelled governors Glenn Youngkin and Ron DeSantis to historic victories. It also changed the course of Andrew's life. After serving as a researcher for the Federal Reserve in Washington DC, an investment banker, entrepreneur, software developer, and author, he put his professional endeavors on hold to devote his life to reclaiming K-12 education.

Andrew and his family, like so many others, left the progressive mismanagement of New York and moved to the Free State of Florida. With the same sense of duty that drove him to write the Brearley letter, Andrew will become the first grassroots leader from the parents movement to run for Congress.

While Andrew is known for his stance on education, parental rights, and defending America's founding principles, he is also a strong proponent of free markets, limited government, fiscal responsibility, and reducing regulations, especially on small business. He strongly favors sane energy policies and energy independence, strengthening our military, mature foreign policy rooted in realpolitik and a defense of western civilization, and unwavering support for Israel.

Andrew is running in Florida's 22nd Congressional District against a highly progressive 6-term incumbent, Lois Frankel, who represents a Democratic party captured by its far-leftist extremists. Marred by scandals, including recent scrutiny over stock trades, Frankel is against protecting girls' sports, hostile to parental rights, an outspoken proponent of Bidenomics, vulnerable on immigration, and supportive of the Squad - the most anti-Israel faction of her party.

Andrew is by far the most competitive candidate for this district in recent memory, and changing demographics work solidly in his favor. CD-22 is no longer a safe Democratic district. Governor DeSantis won Palm Beach County in 2022 - the first time a Republican has won the county in nearly 40 years, and Republican new voter registrations in the district have exceeded Democrat registrations nearly every month for the past two years.

For nearly three years, Andrew has been a leading voice for sanity in the fight against progressive ideology and woke indoctrination. Andrew will continue the fight in Congress to reclaim the values that made America the freest and most prosperous country in the world.
